### **Financial year 2023: InfoGuard increases turnover by 26 percent – and also establishes its cyber defence and incident response services in Germany and Austria**

**Leading Swiss cyber security expert InfoGuard can once again look back on a positive financial year with an increase in turnover to 66 million Swiss francs. The growth of 26 percent compared to the previous year exceeds market levels. The encouraging development and sharp rise in demand in the areas of cyber defence and incident response services throughout the DACH region made a particular contribution to this result. The company will continue its growth strategy in 2024.**

#### **Cyber defence drives growth above market levels**

Total sales rose by 26 percent to 66 million Swiss francs. A key driver of growth is the cyber defence services segment, which grew by 34 percent. Incident response services once again saw a sharp rise in demand: InfoGuard has supported a total of 260 customers in the DACH region in dealing with cyber attacks – an increase of 65 percent. The Security Consulting, Penetration Testing and Managed Security & Network divisions also recorded highly encouraging growth.

InfoGuard currently has over 230 employees, including 18 apprentices. The proportion of women is around 20 percent. Twenty-five new jobs were created. Growth creates an obligation for responsible behaviour. Certification in accordance with the ISO 14001 environmental protection standard in the past financial year underlines the climate-neutral cyber security provider's ongoing commitment to environmental protection and sustainability.

#### **Branching out with subsidiaries in Germany and Austria**

Market development in Germany and Austria, focusing on the areas of managed, cyber defence and incident response services, is progressing successfully. To this end, InfoGuard established and expanded subsidiaries in Munich and Vienna at the beginning of 2023 – and is growing its headcount.

“In this dynamic and challenging market environment, we were able to consolidate and expand our leading position in Switzerland. At the same time, we've successfully gained a foothold in the German and Austrian markets, which are equally important to us, and have won the trust of numerous new customers and partners. That makes us proud!
