### **Financial year 2022: InfoGuard successfully continues qualitative growth**

**Leading Swiss cyber security expert InfoGuard can look back on 2022 as another positive financial year with double-digit overall revenue growth. Strong growth in the areas of Cyber Defence and Managed Security Services as well as rising demand from Germany and Austria contributed in particular to the result.**

InfoGuard AG is on the road to success. As in previous years, the targets for financial year 2022 were exceeded and the strategic plans successfully advanced:

- Total sales were up 10 percent to 52.2 million Swiss francs.
- Cyber Defence and Managed Security Services grew by 43 percent.
- Demand in particular for Incident Response Services increased sharply. In total, InfoGuard helped 158 customers in the DACH region deal with cyber attacks.
- A branch office was opened in each of Munich and Vienna with a total of seven local employees.
- 25 new jobs were created, with the result that InfoGuard now has over 200 employees.
- InfoGuard has been accredited as a member by the FIRST (Global Forum of Incident Response and Security Teams) organisation and as a qualified APT Response service provider by the BSI (German Federal Office for Information Security).

InfoGuard's growth and rapid expansion in Germany and Austria is due in particular to the high demand for Cyber Defence Services, primarily Managed Detection & Response (MDR), CSIRT and Incident Response Services. Consequently, the Cyber Defence Center in Baar/Zug (Switzerland) was expanded to a size of 550 sqm in September 2022. All SOC Services for customers are provided from this location.

"Despite volatile market conditions, we have been able to grow and expand our leading position in 2022. We are confident that our strategy will continue to be successful not only in Switzerland, but also in the German and Austrian markets. We enjoy great trust across country borders and have already been able to win numerous customers and partners, such as insurance companies," comments Thomas Meier, CEO of InfoGuard.

InfoGuard expects further growth in the coming years. This will involve the further expansion of Cyber Defence and Managed Security Services along with an increase in market shares in Germany and Austria. 25 new jobs are planned in 2023 to support this growth.
